DEALER SETUP: Friday 1-8 p.m.. Need to be set up and ready by 8 a.m. Saturday. It is required that all vendors remain set up for business until 3:00 p.m. Sunday. **No breakdown before 3:00 p.m.**

VENDOR SPACE: Antique retail outdoor spaces are 10 feet by 10 feet and are available for \$50.

Vendor is responsible for setting up his or her space in an orderly fashion considering the safety of those who will be shopping. In addition a \$20 refundable deposit is required and will be returned after 3:00 p.m. Sunday.

MERCHANDISE: Vendors may sell antiques and collectibles and vintage, rustic and shabby chic décor. No new items may be sold with the exception of books, catalogs and other peripheral items related to the restoration and preservation of antiques and collectables. In consideration of a family friendly atmosphere, no hate group or sexually graphic materials may be sold.

INDEMNITY: Vendors and their assistants assume all risk of personal injury or property damage not arising out of the willful misconduct of the Operator, the State of Oregon, and the City of La Pine and agree to indemnify and hold harmless the Operator, the State of Oregon, and the City of La Pine for any and all claims cost or expenses incurred as a result of the conduct of Vendors and their assistants.

ELECTRICITY: Electricity will not be available to vendors.

RESTROOMS: Portable restroom facilities will be available during show hours. There is a handicap restroom inside.

LICENSES: Vendors are responsible for compliance with all applicable resale and other license requirements and shall hold Show Operator harmless for any regulatory breach.

INSURANCE: Vendor is responsible for obtaining its own insurance coverage to insure against theft, fire, smoke, flood, or any other loss or injury within Vendor's space.

SECURITY: Show Operator shall provide security personnel to help ensure the conduct of visitors.

PROHIBITIONS: No generators, flammables, or non-complying merchandise shall be permitted in Vendor spaces.

COOPERATION: Vendors are responsible and are to ensure that neither their conduct nor that of their assistants will infringe on the rights of other Vendors or visitors. Vendors agree to conduct their business in compliance with all Federal, State, and local laws.

CLEAN UP: Vendors are required to keep their rented areas clean. Vendors must remove all boxes and other refuse in and about their rental spaces before departing from the show. This will result in the return of their deposit.

I, the undersigned Vendor, have read, understand, and will abide by the terms of the La Pine Senior Activity Center Antique Show Rental Agreement. In consideration of the Vendor's payment of \$50 per space and a \$20 refundable deposit and agreement to abide by the terms of this agreement, the La Pine Senior Activity Center agrees to provide the Vendor access to a designated Vendor space(s) on the day of the event.
